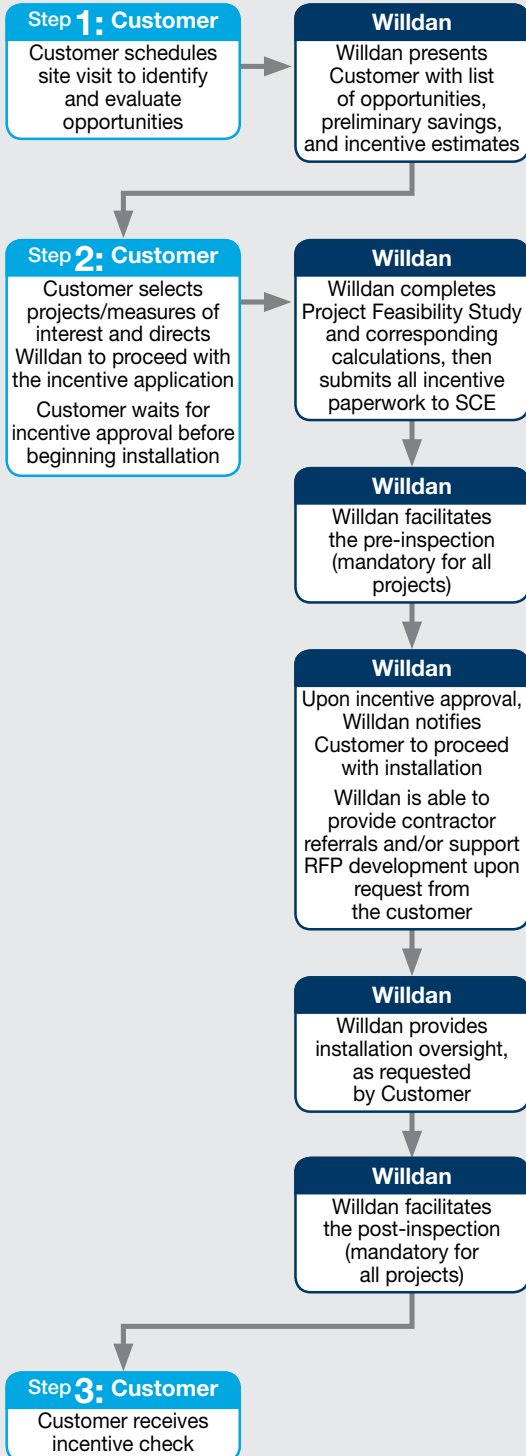

## HOW IT WORKS

Based on the data gathered by Willdan engineers, Willdan creates a Project Feasibility Study identifying recommended energy efficiency measures and the corresponding estimated energy savings, available incentives, and simple paybacks.
